

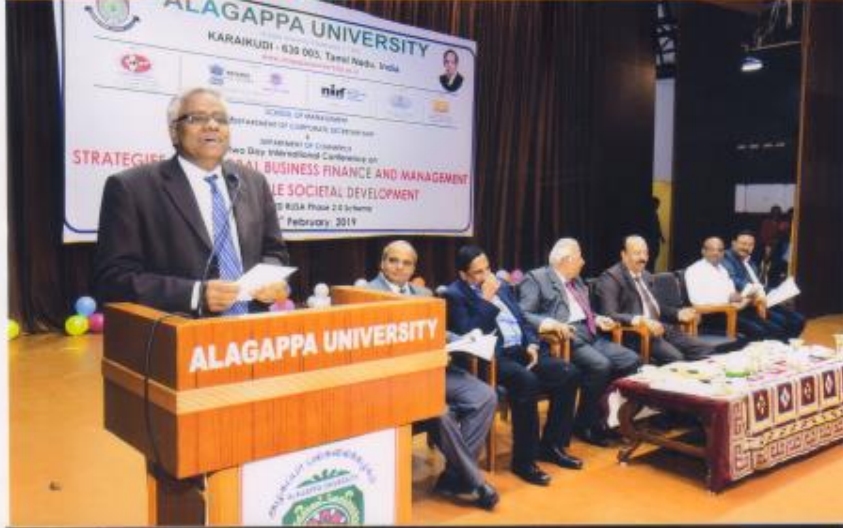

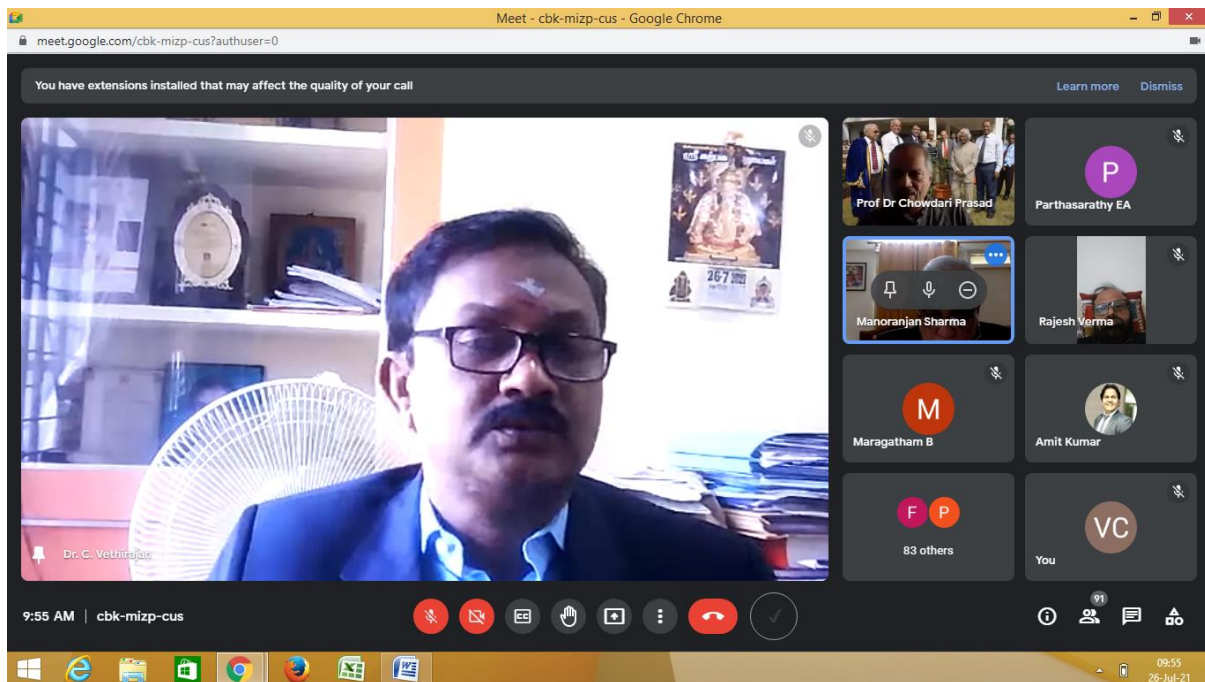




**AICTE Training and Learning (ATAL) Academy Five Days, AICTE Training and Learning Online FDP “Corporate Restructuring of Public**

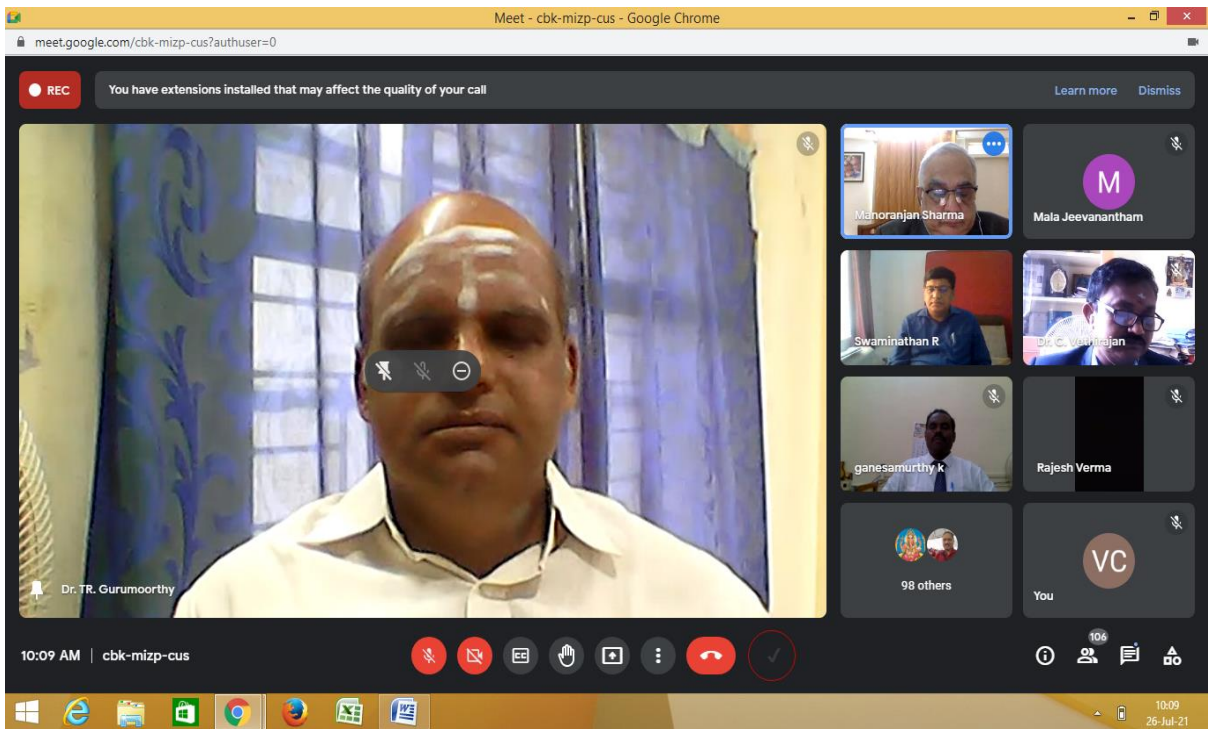
